Verification of Payee (VoP) is a fraud prevention service that confirms whether the name on a bank account matches the account details provided by a payer before processing a payment.

Verification of Payee Requirements

According to the European Payments Council (EPC), Payment Service Providers (PSPs) in the Eurozone must implement a VoP solution by **October 9, 2025**. For non-Eurozone countries the deadline to comply is July 2027.

To perform a verification PSPs will need to confirm a payee's **IBAN** and **name** or other identification code, such as VAT or Legal Entity Identifier (LEI) code.

The required checks apply to **every SEPA Credit Transfer (SCT) and SEPA Instant Credit Transfer (SCT Inst)** transaction and must take place before the payment is initiated. The checks are separate from the execution of the SCT / SCT Inst transaction itself.



VoP enhances trust and prevents fraud, by verifying payee details before payment execution.

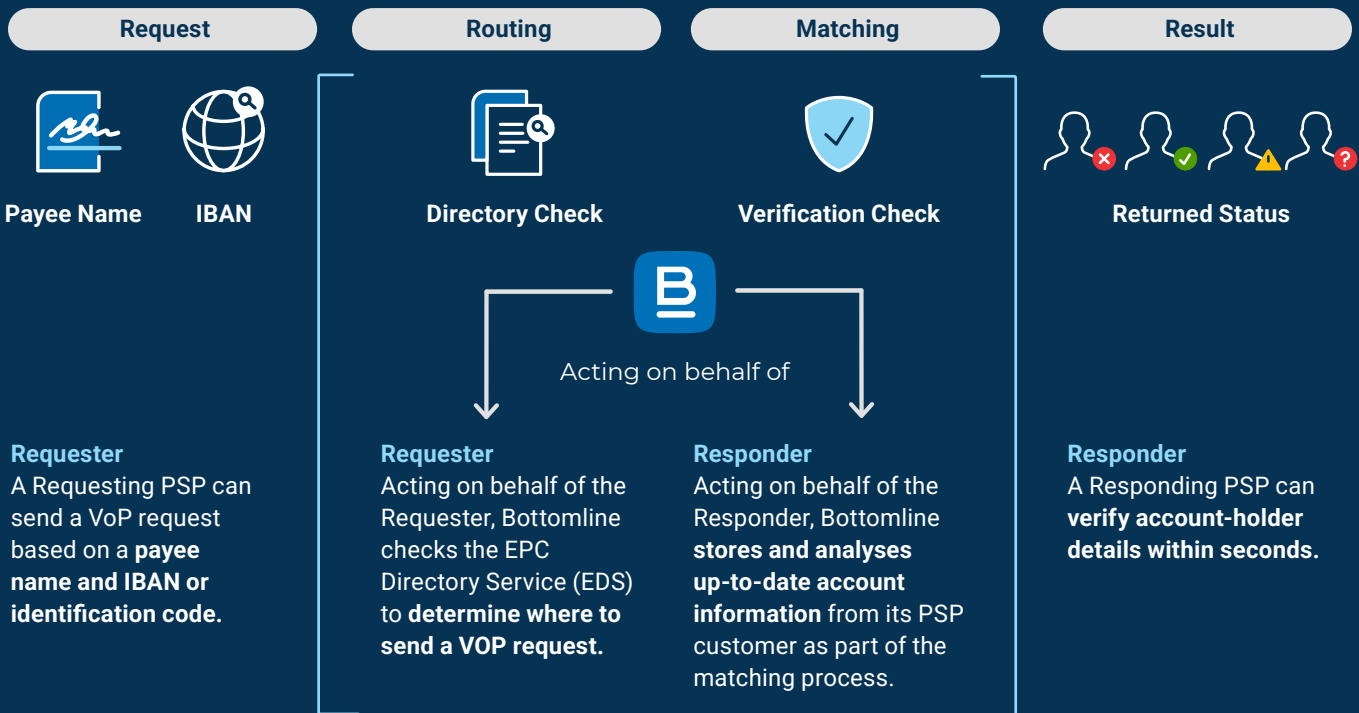
